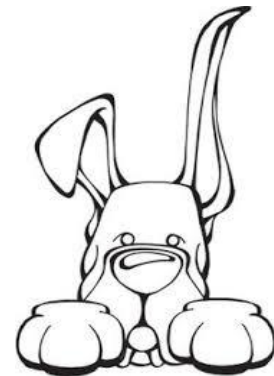

Said puppy is guaranteed to be in good health at the time of pick up or delivery.

The puppy must be examined by a practicing licensed Vet within 2 business days of receiving the puppy. Buyer must return a copy of the vet visit report within one week or the health guarantee will be voided.

The breeder guarantees that puppy has been vet checked and is free of any infectious or communicable diseases. Puppy has had all age appropriate vaccinations and wormings, breeder will provide documentation with puppy.

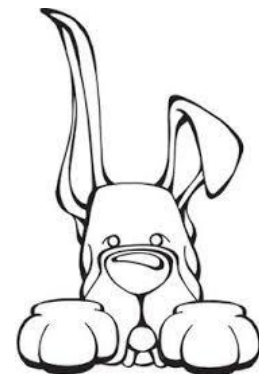
The breeder guarantees this puppy to be free of any congenital (inherited) health problems for a period of one year. Should this puppy develop any of the above health issues after the 72 hr period, no cash refund will apply. breeder will agree to replace the puppy with a pup of comparable value from the next available litter. For this guarantee to apply, the buyer must provide written statement and all vet records from a licensed veterinarian to seller to confirm diagnosis of congenital defects. Breeder reserves the right to have a second vet, of breeders choice to confirm the diagnosis.

The breeder does not guarantee against hypoglycemia or any other common problems such as diarrhea, wormy stool, coccidia, giardia, ear mites, fleas, external parasites or stress due to shipping or new home. This guarantee does not cover kennel cough or parvo, they leave us with their first shots, it is the buyers' responsibility to continue all proper vaccinations. Other minor problems are not covered under this guarantee and are the responsibility of the buyer.

The breeder does not guarantee against skin problems such as puppy acne, ect. This also does not cover HOD, PANO, OCD, and growth related problems, as these are not genetic. This guarantee does not cover what in the breed Great Dane is considered normal, cherry eye, haw eyes, entropion, torsion of the stomach.

Any and all veterinarian expenses are the sole responsibility of the buyer.

No guarantee will be given as to size, color, quality, or fertility.



Completing the puppys puppy vaccinations and annual boosters are required. Owner must be able to provide veterinarian documentation.

The breeder will not be responsible for any accidents that happen after puppy leaves the seller or after being dropped off at the airport to be shipped.

The breeder shall not be held responsible for the acts of the puppy or development of non-genetically derived faults, disease, or disorders after the puppy leaves the breeder.

Minor health problems that can be cured by medical/surgery are not covered by this guarantee.

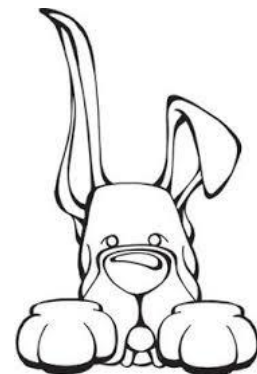
IF AT ANY POINT IN TIME THE BUYER CAN NO LONGER TAKE CARE/WANTS THE PUPPY, THE PUPPY MUST THEN BE RETURNED BACK TO BREEDER DANIELL GRAHAM TO TAKE OVER OWNERSHIP AT NO COST TO HER. ALL AKC PAPERWORK WILL BE REQUIRED TO ACCOMPANY THE PUPPY. VET RECORDS ARE REQUIRED ALSO. THIS WILL HELP ENSURE THAT THE PUPPY IS NOT PLACED IN A RESCUE OR ANIMAL SHELTER.

Buyer also agrees that the puppy/dog will not be given away/rehomed, sold, co-owned/leased. However the breeder Daniell Graham may come to an agreement in switching homes if she feels it will benefit the puppy, and there must be a written agreement.

Buyer agrees that puppy will be treated as a family member and be given adequate food, shelter, and veterinary care for his/her lifetime. Breeder is not under any circumstances responsible for any vet bills incurred at this time.

Buyer agrees to send photos and current size and growth info of this puppy/dog at least every 2 to 3 months during the first year and at least yearly thereafter.

If the buyer should break any part of this contract at any point in time then buyer acknowledges that the guarantee is voided, except the section pertaining to the buyer not being able to care/want the puppy clause will still be in effect.



I give you a lifetime breeder support guarantee. If at any time you have any questions or concerns please contact me and I will help you the best that I can. These babies are part of my family and I want to watch them grow and know that they are in good homes.

This contract of sale contains the entire agreement between both parties. All implied guarantees are hereby excluded.

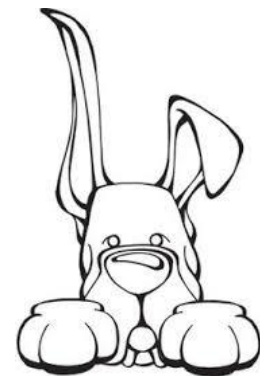

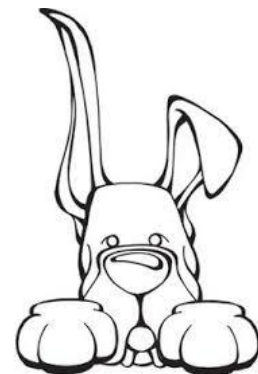
Failure to do so, warrants immediate return of the pup to breeder at new owners expense.

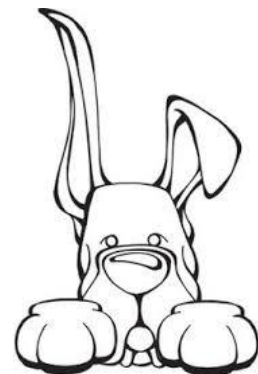

For Co-Own only contract:

- The Co-Owner agrees to have this bitch fully health tested and certified by OFA before any breeding takes place.
- The Co-Owner must notify the breeder of first heat and all heats thereafter and also all ties made between the bitch and stud until contract agreement is fulfilled.
- All expenses of routine veterinary care, feeding, housing, and care for the bitch and any litters she produces are the sole responsibility of the Co-Owner.
- Co-Owner must provide proof (ultra sound or x-rays) to confirm bitch is pregnant.
- Co-Owner must keep breeder UTD throughout the pregnancy, birth, and the 8 week period thereafter while the puppies are in Co-Owners care, this includes providing pictures, growth info, or any concerns for any puppy as the puppies grow.

Breeder will drop the full registration price down to \$_____ with POL back from first litter. In which this means you will pay the full price mentioned above before taking on ownership of said puppy for full registration plus give breeder the POL or the price of one puppy which will be breeders choice from the first litter that said puppy produces. Breeder must approve stud for this breeding. If by any chance and for any reason this puppy does not produce a litter from the time she is 2years of age until she is 3 years of age then owner agrees to pay the full amount of \$_____ in which the puppy would have sold for, then the co-own section of this contract will have been served and nothing is further expected from either party.



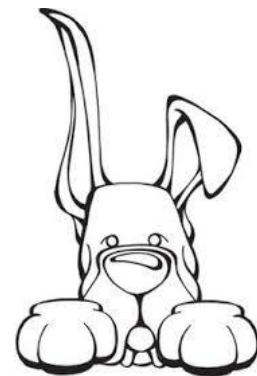

For full registration contract:
