I _____ agree to pay the stud owner Daniell Graham the amount of \$2000.00 for stud fee before breeding takes place.

I _____ agree to take POL plus \$500.



All fees are payment for the stud service only and are not to be construed as a guarantee of puppies. If the bitch fails to whelp or whelps fewer than two living puppies at birth, the owner of the bitch must notify the stud owner within 65 days after the date of the last mating. There shall be no refund in full or partial, but a return service to the same stud shall be provided at the same bitches' next heat if both are still available; if not available, to an agreed alternate.

If the bitch fails to whelp or give birth to two living puppies as a result of this second mating, then this agreement shall be terminated and the stud owner shall have no further obligations.

The following items are needed prior to or at the time of the first mating:

*Current vaccinations and worming record.

*Health Certs.

*AKC Registration papers.

*Four Generation Pedigree.

*Current Negative Brucellosis test results performed within 14 days of the expected breeding.

Bitch must be registered by the American Kennel Club and be over 24 months of age.

Bitch must be certified clear of Canine Hip and Elbow Dysplasia, cardiac disorders, and thyroid disorders by the Orthopedic Foundation for Animals and the results shared with stud owner prior to first mating.

Any and all genetic and/or health problems which exist or have existed in the bitch must be disclosed to Stud Owner before breeding takes place.



Bitch must have good temperament and be available for examination by stud owner if stud owner wishes to do so.

Bitch owner warrants that this bitch has not been exposed to any other intact male dog from the start of her heat cycle and will not be exposed to any other intact male dog throughout the entirety of her heat cycle.

A stud fee of \$2000.00 shall be payable in full prior to the first mating by cash or certified check only. Unless agreed to POL plus \$500 in which the stud owner chooses.

It is agreed that the stud owner is not obligated to sign the application for registration until the stud fee is paid in full or POL is in possession of the stud owner. Nor is the stud owner required to sign the application if any part of this contract has not been followed.

The bitch owner is responsible for any and all fees associated with breeding, including but not limited to veterinary services, shipping fees, and ovulation timing.

The stud fee shall not be refunded, in whole or part, for any reason, except for the above mentioned reasons.

While the bitch is in the care of the stud owner she will be treated as one of theirs. Stud owner agrees to keep the bitch to inaccessible to all other male dogs until the bitch has been bred and returned to owner.

The bitch owner agrees that all puppies resulting from this litter will be properly cared for and placed in the proper homes.

No puppy resulting from this litter shall be either directly or indirectly transferred to wholesale outlets, humane shelters, or pet shops.



Bitch owner agrees to sell all puppies on a written contract. Copy of this contract must be furnished to stud owner prior to first mating.

Furthermore, stud owner reserves the right to deny any breeder or bitch for any reason. In the case that the breeding has previously been approved, stud owner also reserves the right to refuse any bitch that is aggressive for any reason while attempting to breed, in this case the stud fee, less \$200 for expenses, will be refunded.

There is always a risk when breeding that may be injured during the process. Bitch owner agrees to hold the stud dog harmless from any liability or damage. In addition, the bitch owner understands that the stud owner accepts no liability for the actions of this bitch while in their care, including but not limited to personal injury or property damage.

The bitch owner agrees to have an ultra sound done 35 days after the first mating to ensure wether the bitch is pregnant or not.

When the litter is born, the stud owner is to be notified. The stud owner is granted permission to use the bitches pictures in relation to the litter and advertising. The stud owner also reserves the right to take/or request pictures of the litter for her records.



I/We the undersigned, have thoroughly read and understand the contents of the entirety of this agreement and acknowledge this to be a true and binding contract. By the signing of this contract, I/We, do hereby agree to abide by its terms and conditions. The party in default will pay for any and all legal fees, incurred in the enforcement of this contract.
